Initiating the discussions, the Deputy Commissioner cum Chairman, District Level Monitoring Committee(DLMC) had informed the house about constitution of the District Level Monitoring Committee alongwith its Members, functions, aims and objectives of the Committee for reviewing quarterly, the schemes sanctioned under SPA(Special Plan Assistance), ACA(Additional Central Assistance), RIDF(Rural Infrastructure Development Fund), NLCPR(Non-Lapsable Central Pool of Resources), Prime Minister's Package and schemes sanctioned by NEC(North Eastern Council), Shillong in Changlang District.

Thereafter department-wise sanctioned schemes of the above mentioned programmes were reviewed one after another. The Chairman asked the departments for proper implementation of these schemes speedly with judicious utilization of funds. After long discussions and review all the schemes, following decisions were emerged:-

- Concerned Executing Agencies will inform progress of works including sanctioned amount of each schemes, physical targets, financial achievements of the above programmes to the concerned ZPMs and Administrative Officers. A copy of which is also to be given to the Deputy Commissioner and DPO cum Member Secretary of the District Level Monitoring Committee from time to time.
- Concerned Administrative Officer and ZPM should also regularly monitor the progress of the schemes and report may be submitted to the Chairman Monitoring Committee from time to time.
- From next meeting all the concerned Head of Department must attend the meeting without fail, in case any unavoidable reasons the subordinate officers who represents the meeting should have through knowledge about all the schemes of his department and can reply all the questions raised by the Members.
- ADC Miao and Zilla Parishad Chairman, Changlang District will short out the problems faced by the Executive Engineer, Department of Hydro Power Development, Bordumsa to lift the materials for construction of Hydro Power Projects at Vijaynagar.
- Executive Engineer, PWD Changlang is to submit details of fund allotment including physical progress, financial achievements etc of Margherita -Changlang
