

MINUTES OF THE FIRST DISTRICT LEVEL MONITORING COMMITTEE MEETING HELD ON 10-12-08 AT 1030 HRS IN THE OFFICE CHAMBER OF DEPUTY COMMISSIONER ANINI, DIBANG VALLEY DISTRICT, ARUNCHAL PRADESH.

In pursuance of Government letter no. PD(NLP)28/2007 Dated 04/11/2008, the first meeting of District Level Monitoring Committee was held on 10-12-08 [Wednesday] in the office Chamber of Deputy Commissioner under the Chairmanship of Shri Duryu Ranka Deputy Commissioner, Dibang Valley District to discuss for Monitoring the various Schemes under ACA, SPA, NEC, NLCPR, RIDF, PM's Package etc. for proper implementation and timely completion of these projects for Dibang Valley District.

Assuming the Chair, the Deputy Commissioner welcomed all the Members present. Chairman informed the house that the meeting is aimed at having an overall view of the progress of the centrally sponsored schemes as most of the Member are not aware of the schemes. He further informed the house that a third party NABCONS visited the District for Physical Monitoring of the implementation of the schemes. He made the house aware of the Government's Notification No.PF(NLP)-28/2008 Dated Itanagar, the 27th June 2008 regarding the District Level Monitoring Committee Constituted for the District by State Government with the following composition to monitor the various schemes under ACA, SPA, NEC, NLCPR, RIDF, PM's Package etc.

1. Deputy Commissioner - Chairman
2. Concerned Administrative Officer (i.e ADC/SDO/EAC/CO of the Area) - Member
3. Concerned Head of the Implementing Agency - Member
4. Concerned Head of the Beneficiary Department/Organisation - Member
5. Zilla Parishad Member of the area - Member
6. District Planning Officer - Member Secy

Deputy Commissioner requested all the concerned implementing Agency should submit the relevant details of the Project to the office of Chairman District Level Monitoring Committee for proper Monitoring.

Shri Empi Meya, Chairperson Zilla Parishad Anini sought detailed information, Guidelines pertaining to the funding and execution of all the Centrally Assisted Projects in the District from the concerned implementing Agency(ies). He called upon the Heads of the Department of the District to involve Panchayat Leaders in implementing various Centrally Sponsored Scheme (CSS). Meya appealed all the concerned implementing Agency to provide details of Schemes before being carried out to all the Panchayat Member of District so that the elected Panchayat Leaders are not in darkness about the schemes. This would help them in proper Monitoring and implementation of the schemes, he added.

Er Robin Nani Executive Engineer PWD Anini Division highlighted in details the 32 (thirty two) nos. of centrally Sponsored Projects in respect of Dibang Valley District are being taken up by the Department. The work on these projects is going on. He assured that the Department would be able to complete the 32(thirty two) nos of Projects within the stipulated time. He clarified that 32(thirty two) nos of Centrally Sponsored Schemes are being executed as per the Norms of the Department. For effective Implementation of the Schemes and Proper & Uniform development of the District elected leaders and Govt Officers should work hand in hand.

Smt. Mita Mihi, ZPM Anini-Mipi-Aliney CD Block urged for the Judicious utilization of Centrally Assisted Fund which should benefit all the people of the District and avoid duplication of the works. She appreciated for the Constitution of District Level Monitoring Committee for the successful implementation of the various projects in the District.

Shri Unty Ekru, ZPM Anelih-Arzo CD Block urged for more transparency in execution of the schemes by the concerned working Agency(ies) and asked the department heads to facilitate the flow information of the projects whenever asked for.

Er Lod Nakku, AE Hydro Power Anini informed the house that the 03(three) nos. centrally Sponsored Projects namely Augmentation of Awapani MHS (2x250 KW) at Aliney for Rs. 89.72 lakhs, Renovation & Modernization of Awapani MHS Phase-I (3X50 KW) at Aliney for Rs. 63.83 lakhs and C/o Echi Ahfra MHS(2X200 KW) near new Anaya for Rs. 30.01 Lakhs under PM's Package funded for Dibang Valley District are being executed by the Department. The Projects will be completed in time, he added.

Er D.R Ram, AE RWD Anini Sub-Division briefed that 02(two) nos. project namely Construction of Steel Truss Bridge over Dree Rier at Angrimvalley for Rs. 213 Lakhs under RIDF and Constrution of RLR from Angolin to Kadeli village for Rs 31.02

Lakhs under PM's Package are being executed by RWD in Dibang Valley District. He informed the house that the work on these projects are in progress.

Shri T.Dupak EAC i/c DPO Cum Member Secretary DLMC , Shri Sipok Lombi CO Mipi, Shri J.Lamdik i/c Project Director and Shri D.Lollen DDSE Anini also spoke on the occasion.

After threadbare discussion, the house unanimously resolved the following:-

1. For all round development of the district, the District Level Monitoring Committee will monitor the Centrally Sponsored Projects Progress in the District. The Details of the Projects like progress report, Estimate of the scheme etc be provided regularly to the Chairman of the District Level Monitoring Committee by the concerned implementing Agency for monitoring without waiting for any circular from the office of Chairman DLMC. The Monitoring report of the field visits by District Level Monitoring will be forwarded to Government for further necessary and corrective actions.
2. All the concerned implementing Agency be ensured to execute the Projects within the schedule time and maintain the quality.

The meeting ended with vote of thanks from the chair.
