At very out set Chairman of DLMC, Shri Marnya Etc, IAS, welcome the Members present and read out the Govt. notification No. PD (NLP)-28/2007 dtd Itanagar the 27th June 2008 regarding the constitution of District Level Monitoring Committee with special emphasis on PM's package and other centrally sponsored schemes. He appealed that fund provided by the Govt. should be judiciously and properly utilized and physical completion of the schemes should be ensured. Thereafter, the committee discussed on the various aspects of implementation of the schemes for the

Executive Engineer, PWD, Executive Engineer, Electrical, Executive Engineer, HPD, ANCO, RWD, PD, DRDA, AUPO, UD, presented before the committee up-to-date information on the various schemes being implemented through their department. Earlier, EE PHED, Bomdila had informed over Telephone that due to some official engagement he was not in a position to attend the meeting and he would submit a detail report to the Chairman. After a threadbare discussion committee took the following decisions:-

1. Due to poor or lack of connectivity Net Accessibility is not always possible and hence it was decided to request Commissioner/Secretary, Planning to send detail list of schemes sanctioned under centrally sponsored programmes particularly under PM's Package and NEC. For better and effective monitoring copy of the sanctioned schemes may also be endorsed to concerned administrative officers.
2. Committee decided to hold its next meeting in the second week of January 2009.
3. Committee also decided to seek clarification from the Govt. as to who schemes like public toilet, cultural and community halls should be handed over for future upkeepment.
