I am directed to convey the sanction of the Secretary, NEC to the payment of Rs.28.4 lakhs (Rupees Twenty Eight Lakhs Forty Thousands Only) only to the state Government of Arunachal Pradesh towards 1st installment of grants under North Eastern Council for the purpose of " Financial Assistance towards Automation of Manual Inner Line Permit System in Arunachal Pradesh" by the Deputy Director Arunachal Pradesh State Council for Science & Technology, (Department of IT and Science & Technology Govt. of Arunachal Pradesh). During the year 2009-2010 approved vide order NO.NEC/ST/AP/537/2008 dated 22nd March, 2010.

2. The grant is towards plan expenditure and should be utilized on the programme as per approved guidelines of North Eastern Council and no deviation from the provisions of guidelines is permissible.
3. The State Govt. should release its share immediately on the receipt of this Central share for this programme as per guidelines of this scheme.
4. The State Govt will furnish the certificate of actual utilization of this grant within twelve months of the closure of accounts. In respect of expenditure by the state Govt. through local bodies or private institutes, the utilization certificate is required to be furnished by the state Govt.
5. The entire assistance in the form of grant is provisional and is subject to adjustment on the basis of audited figures of expenditure of the North Eastern Council Plan Scheme for 2009-2010.
