I am to forward herewith a copy of Guidelines for Developmental Activities of NON-BADP Assembly Constituency as approved by the Government of Arunachal Pradesh for your kind perusal/references on implementation of Developmental Activities of NON-BADP Assembly Constituency schemes please.

While preparing AAP, following points shall be adhered to:-

- 2. The Deputy Commissioner shall prepare Annual Action Plan(AAP) after consulting all the stake holders and MLAs.
- The projects to be undertaken under "Non-BADP Fund" shall be finalized/ approved by the concerned DC and a copy shall be submitted to Planning Department for releasing of 2nd installment fund
- 4. The nature of scheme should be to meet critical gap in infrastructure as per the felt need of the Assembly Constituency with an emphasis on creation of durable and tangible assets in Assembly Constituency
- 5. The projects should be confined to the Assembly Constituency (not covered under BADP).
- 6. The schemes should be implemented only after obtaining Administrative Approval/Expenditure Sanction/Technical Sanction as per CPWD Manual and financial Concurrence wherever necessary from the competent authority. It should ensured that provisions prescribed in the DPR, DFPR, CPWD Manual and all the circulars, directives OMs and orders issued by CVC, GOI, MoF and the State Government is strictly adhered to.
- 7. Selection of schemes should be made as per the prescribed guidelines.
- The expenditure is debitable under Major Head "4070" Capital outlay on Other Administrative Services - Sub Major Head- 00 Minor Head - 800- Other Expenditure –Sub-Head-11-NON-BADP FUND-detailed Head-00 Object Head-530- Major works, Demand No -50.

GUIDELINES FOR DEVELOPMENTAL ACTIVITIES OF NON-BADP ASSEMBLY CONSTITUENCY. '2018

1. OBJECTIVE:

The main objective of the scheme is to develop developmental infrastructure in the assembly constituencies which are not having any border blocks. The list of such Assembly Constituencies is attached as Annexure A. The scheme has been built to provide equitable development and distribution of resources in the state.

2. SALIENT FEATURES OF THE SCHEME:

Each Deputy Commissioner shall prepare Annual Action Plan (AAP) after consulting all the stake holders and MLAs. To make the process faster the Annual Action Plan will be approved by the Deputy Commissioner and a copy shall be submitted to Planning Department. The activities permissible under Annual Action Plan are mentioned in Para-4.

The nature of scheme should be to meet critical gap in infrastructure as per the felt need of the Assembly Constituency, with an emphasis on creation of durable and tangible assets in the Assembly Constituency.

The schemes selected shall be confined to the Assembly Constituency-not covered under Border Area Development Programme (BADP). Villages covered under BADP are not eligible under this scheme and they should be totally excluded.

The schemes should be implemented only after obtaining Administrative Approval/Expenditure Sanction/Technical Sanction as per CPWD Manual and financial Concurrence wherever necessary from the competent authority. It should ensured that provisions prescribed in the DPR, DFPR, CPWD Manual and all the Circulars, directives OMs and orders issued by CVC, GOI, MoF and the State Government is strictly adhered to.

3. ACTIVITIES PERMISSIBLE UNDER THE SCHEME:

The main focus of the scheme is to create tangible infrastructure in the district. The allocation in various sectors under the scheme is given which will be followed while preparing Annual Action Plan:

The work undertaken in the scheme should not be less than 5 lakhs in each case.

4. ACTIVITIES NOT PERMISSIBLE UNDER THE SCHEME

The following activities are not permissible under the scheme:

- a) Office buildings, residential buildings and other buildings of registered societies, private individuals or cooperatives.
- b) Grants and Loans.
- c) Memorials or Memorial buildings.
- d) Land compensation.
- e) Places of religious worship.
- f) Boundary walls/retaining walls of nallahs/ponds.
- g) Purchase of vehicles of any kind.

5. MONITORING OF THE SCHEME

Annual action plan once approved, will not be changed until specific approval of the Secretary (Planning) is obtained. The entire infrastructure created under the scheme will be geo-tagged by the executing agency and entries of the same will be made in the MIS developed by the Planning Department. Planning Department will also have the right to constitute third party monitoring committees to inspect the works. Quarterly Progress Reports will be submitted by the Deputy Commissioner to the Planning Department.

6. ALLOCATION OF FUNDS

The funds allocated under the scheme will be transferred to the districts by the Planning Department in three instalments. The first instalment (50% of the allocated amount) will be released in the month of June. The second instalment will be released by the first week of December (25% of the allocated amount). The second instalment will be released by planning department only after receipt of Annual Action Plan from the district. The third instalment will be released in the month of March (remaining 25%).

Fund can be converged/ dovetailed with Central sponsored scheme/ Central Sector Scheme/ State Government schemes, provided such schemes are eligible and permissible under the guidelines.
